Instructions and special considerations for contingency situations

Planning for the Unexpected

Ensuring you're able to provide superior and uninterrupted service to your members is our number one priority at Corporate One. However, there are a number of external circumstances that can make that objective even more challenging. Our Contingency Services Guide is designed to provide the critical information you need, when you need it, to ensure continuity of services from Corporate One to your credit union, and finally, to your members. Please use this guide, and share with staff, when situations arise whereby you are forced to operate your credit union in contingency mode. The Guide lets you know of many of the ways we can assist in a contingency situation.

First and foremost, anytime you have advance notice that you'll be running in contingency mode, contact us as soon as possible. There are several ways we can assist your credit union with alternative solutions to help you manage through whatever crisis you may be experiencing.

Security and IP Lockdown

Maintaining security is essential in any contingency plan. If your credit union takes advantage of Corporate One's IP Lockdown security feature, you'll want to contact us should you need to work from an alternative site(s). We have the ability to enable or disable this feature, but it's important for you to advise us should you wish to modify it. Otherwise, you and your staff will be unable to access many of Corporate One's services through Members Only (Corporate One's online member portal.)

Online Access to Services (Members Only)

Unless the IP Lockdown security feature is enabled (see above), Members Only can be accessed from any internet connection. The link to Members Only can be found at the top of our home page, www.corporateone.coop. Most of the services can be accessed through single sign-on (SSO) functionality. Therefore, it's important to ensure necessary staff have their Members Only user ID and passwords, along with their grid card (or token if applicable).

Account Management (Member\$MART)

To manage your account online in Member\$MART, Corporate One's account management application, your staff will need their Members Only credentials (see *Online Access to Services (Members Only)*) to access the application from the Members Only link on www.corporateone.coop.

Should you be unable to access Members Only, our Member Experience team will be available to assist with account balances, transfers, etc.

Cash

In contingency situations, you may see an increase in the demand for cash. Your credit union will want to assess if additional cash is needed for each of your branches. If a temporary limit increase is needed, please fill out the Vault Over Limit Request form located in the Member Resource area of Members Only, or contact Member Experience.

Should you have difficulty accessing Members Only to order cash, you can also order online using this link: jpmorganchase.com/webcash. You will need your current User ID and password to access the system.

You may also order directly with J. P. Morgan Chase Cash Services by calling 866/218-2858. Your credit union access code will be required.

For orders outside of your normal delivery time, you will need to contact your courier for pickup and delivery options.

Funds Transfers (Wires)

For credit unions needing access to OneWire Domestic, staff will need their Members Only credentials (see *Online Access to Services (Members Only)*) **and** their OneWire Domestic User ID and password to access the system from the Members Only link on www.corporateone.coop. Authorized OneWire Domestic wire users may also call in wires, but will need their caller ID and PIN.

For credit unions needing to access OneWire Global, our international wires platform, staff will only need their Members Only credentials.

- ★ For OneWire Domestic – Cutoff times are 5:15 p.m. ET for call-ins and 5:45 p.m. ET for online.
- ★ For OneWire Global – The cutoff time is 4:00 p.m. ET.

Payment Services

★ ACH and Returns

For credit unions needing to access Corporate One's ACH services, staff will need their Members Only credentials (see *Online Access to Services (Members Only)*) to access the system from the Members Only link on www.corporateone.coop. In a contingency scenario, Receiving Depository Financial Institutions (RDFIs) may benefit from an Excused Delay. Excused Delays apply to processing delays caused by an interruption of communication, or computer facilities that are out of the control of the credit union, due to an act of God or war. Under this NACHA provision, you can submit your ACH returns after you return to normal operations. Alternately, Corporate One Member Experience staff may be able to assist you with manually submitting ACH Returns or approving Origination files for you. Manual return fees will be waived.

Please note that you will need existing authorities in ACH Services in order for us to assist with manual ACH transactions.

Deadlines for ACH processing (unless under Excused Delay):

- ★ 9:00 a.m. local time for processing incoming ACH receipt files
- ★ 10:00 p.m. for sending ACH origination files



★ Remote Deposit Capture

Operations and support for this service is normally available until 8:00 p.m. ET, but we will extend operating hours, if needed, to process your deposits. You can reach us up until 10:00 p.m ET by calling a Production Specialist at 614/825-9371.

For credit unions who are unable to run their incoming deposited items at their branch, these items can be deposited at another branch. Contact Member Experience to assist with that process.

For Deposit Returns, if the items are not decisioned by 4:00 p.m. ET, they will be processed as chargebacks and not redeposited. However, these items can be redeposited at a later date.

★ Share Drafts and Returns

Share draft files are transmitted daily. Should your credit union be unable to retrieve these files due to contingency-related issues, Corporate One will retain copies of the files and will transmit them to you once your credit union is able to receive them.

Operations and support for Share Draft Returns is 5:00 p.m. ET, but can be extended if needed. If you are unable to submit your return files to us, please contact Member Experience and we can manually enter returns for you and will waive any late fees.

To retrieve your Share Draft Files or submit returns, there are two options:

- a. For members who use Members Only to download and upload files, you'll want your Members Only credentials (*see Online Access to Services (Members Only)*).
- b. For members using FTP Services, you can access your files with just your FTP Services credentials. The site for FTP Services is ftpsecureconn.corpone.org.

Loans/Liquidity

In the event of your credit union operating in a state of contingency, we are prepared to fund your liquidity needs to help facilitate cash orders, cover unique settlement activity or address any other circumstance. The following options are available to members in need:

- ★ Available credit beyond the established credit line.
- ★ Reversal of settlement loan interest.
- ★ Reversal of overdraft loan interest and fees.
- ★ Special discounted loan rates available upon request.

Investments

For any of your investment needs related to Corporate One Term Certificates, SimpliCD or Securities while you may be operating in a contingency state, the Investments department will be available for any of your needs, providing:

- ★ **Corporate One Term Certificates** – We can place new term certificates and/or backdate for planned new investments that you were unable to place.
- ★ **SimpliCD** – If you have access through Members Only, you will be able to execute purchases and perform other online services. If you do not have access, contact the Investments department so that our Senior Investment Representatives can enter trades on your behalf.
- ★ **Securities** – Please contact the Investments department.
