The annual CUNA Awards bestow the highest honors to credit unions that are making a difference around the country.

CUNA has recognized Redstone Federal Credit Union in Huntsville, Alabama with the Desjardins Adult Financial Education Award in the more than \$1 billion asset-size category. This award recognizes leadership within the credit union movement on behalf of financial literacy for members and nonmembers of all ages.
